## NATIONWIDE WAIVER-EXTENSION 7

As you all are aware that the Espanola Public Schools is participating in the Summer Food Service Program (SFSP) in July 2022. It was brought to our attention that a Nationwide Waiver to Allow Non-Congregate Feeding for Summer Operations has been extended. What this means is that starting on Monday, July 18 a child age 1-18 can take a meal off site. There are a few rules that must be followed which are listed below:

1. Meals are only served to children 1-18 and at the serving times.
2. Children 1-18 must be present to receive a meal. Once meal is received they may go off site or eat at the supervised site.
3. Breakfast and lunch cannot be served at the same time, meaning only one meal given out at a time. Example: if child is there for breakfast, only breakfast will be given out but that same child may return for lunch.
4. Children may not receive meals for siblings at home, siblings must be present. A parent may **NOT** pick up the meal for a sibling at home.
5. No multiple meals for multiple days will be served.
6. No bus routes. All meals must be picked at an approved SFSP location
7. No bulk meal drop-off points.
8. No door to door delivery of meals.
